Be it resolved Section 14 of Town of Gaines employee handbook be changed to the following: EMPLOYMENT/APPOINTMENT OF RELATIVES (NEPOTISM) Town government requires the establishment of policies regarding the employment of immediate family and members of the same household in order to avoid conflicts of interest or the perception of favoritism and to assure and maintain accountability.

The Immediate Family or any member of the same household of current Town of Gaines employees will not be employed by the Town of Gaines under any of the following circumstances:

- 1) When one of the parties would have authority or practical power to supervise, appoint, remove, influence salary or compensation decisions or discipline the other:
- 2) When one party would handle confidential material that creates improper or inappropriate access to that material by the other;
- 3) When one party would be responsible for auditing the work of the other; or
- 4) When other circumstances exist that might lead to potential conflict among the parties or conflict between the interest of one or both parties and the best interests of the Town of Gaines.
