Attorney Meier drafted a letter stating that the request was too broad as well as not in the best interest of the town due to security concerns.

Supervisor Culhane informed the board that 2 checks had been forwarded to USDA to pay down the principle of 2 water districts that had been over levied.

Supervisor Culhane informed the board that Career Ventures, our cleaning service was imposing a 9% increase on January 1. She explained we were not happy with the service and had negotiated to have the 2014 rate held as is for the month of January 2015 on a trial bases. The day crew will now clean on Friday afternoons.

Supervisor Culhane explained that due to poor service from West Fire she is has requested a quote from ADG for security services.

Supervisor Culhane announced that David Rustay would be returning to work on January 5th.
