**Gilbert Creek:** stream; 6.5 mi. long; heads in Gaines Township at 43°16'56"N, 78°11'03"W, flows N then NNE into Carlton Township to enter Marsh Creek 2.4 mi. S of Lake Ontario; the name honors Elizabeth Gilbert, first pioneer settler in Orleans County; Orleans County, New York; 43°20'29"N, 78°07'59"W; USGS map – Kent 1:24,000.
