#### Proposed - Local Law #1 of 2018

Current 665(b) of Zoning Law

Proposed 665(b) of Zoning Law

**b)** The maximum gross density of the farm labor housing shall not exceed six (6) dwelling units or single wide trailers per acre. The occupational density shall not exceed ten (10) persons per dwelling unit, or six (6) persons per single wide mobile home or ten (10) persons per double wide mobile home. All occupational density standards shall comply with Orleans County Health Department rules and regulations. b) The maximum gross density of farm labor housing shall not exceed six (6) dwelling units, or (6) single wide trailers, or (3) double wide trailers per acre. The occupational density for each dwelling unit, single wide, or double wide mobile home shall be the greater of (i) the number of sleeping quarters containing at least 50 square feet of floor area for each occupant over the age of 2 years, or (ii) the square feet of floor area for each occupant over the age of 2 years pursuant to applicable Federal, State, or local Health Department rules or regulations governing occupational density standards for Migrant Farmworker Housing."

### Action on Town Hall Cupola

- Grant for Town Hall Renovations included a matching component of \$50,000, bringing total project to \$125,000
- Current Expenditures on renovations: \$116,405
- Supervisor recommends repairs as originally proposed (\$5,600) to be part of grant project

#### Action on Town Website

- One-time Design cost \$1,350
- Monthly Hosting cost \$17.99 (This amount is already being spent with current provider just a change in provider)

Purpose

- Improve video surveillance software and hardware
